- 1. The general meeting of the Perth Elks Lodge # 362 was held on Thursday, 9th November at 6:05 PM with ER Les Smith presiding.

 construction of a ramp off the front entrance. Temporary signs will be installed from the parking lot
 identifying the location of the ramp, as well as caution for falling ice and snow.
